SCHEDULE OF SEWER SERVICE RATES, CHARGES, FEES AND SURCHARGES

Effective July 1, 2020

The following sewer rates, charges, fees and surcharges are assessed and payable pursuant to the Hilmar County Water District Sewer Ordinance (Title 5 of the Hilmar County Water District Code).

I. SEWER FACILITIES FEES - [(See Section 5.15.005 (Formerly Section 1202)]

V. SEWER SERVICE CHARGES AND RATES - [(See Section 5.15.015 (Formerly Section 13.01)]. Adopted by Ordinance No. 2010-1 effective July 1, 2010.

A. BASE RATES FOR SEWER SERVICE

The monthly Base Sewer Service Charge for all Residential units will be the Fixed Charges set forth below. The monthly Base Sewer Service Charge for Commercial and Institutional customers will be the greater of the Fixed Residential Base Charges or the Volume Charges set forth below.

B. ADJUSTMENTS TO BASE SEWER SERVICE CHARGES

Unless otherwise indicated, commencing July 1, 2014 the Base Sewer Service Rates and Charges described in A above shall be adjusted annually on the 1st day of July of each fiscal year by an amount equal to the percent change in the All Urban Consumers Index, U.S. City Average (USCA), as supplied by the Bureau of Labor Statistics on the 1st day of January immediately preceding the July 1st date of adjustment, unless or until such time as new rates are set by the Board of Directors. The amount of such adjusted Base Sewer Charges shall be computed as follows:

$$\text{Adjusted Monthly Sewer Service Charge Rate} = \frac{\text{Current Year Consumer Price Index (USCA)}}{\text{Ending Scheduled Year CPI (USCA)}} \times \text{Base Sewer Service Charge}$$

VI. GUARANTEE DEPOSIT (also sometimes referred to as a SERVICE AGREEMENT CONNECTION CHARGE) - (See Section 5.16.003)

VII. RECONNECTION CHARGE – (See Section 5.12.007 Chapter 5.12) (Formerly Section 1204)

VIII. PENALTY FOR LATE PAYMENTS - (See Section 5.13.015 (Formerly Section 1008)]

Effective April 1, 2020 (Resolution No. 531), a late fee of \$10.00 will be assessed on the past due bill on the 25th of the month at 8:30 a.m. The late fee will be applied to any account with a past due balance of at least \$20.00.
